The GOOD NEWS is that the median price of homes in NYS has been climbing for 17 consecutive months in year-year comparisons. The number of sales declined in September for the first time since August of 2020.

Closed sales for August 2021 were up +16.9% year-year. Median Sales price was up +29.9% and homes for sale...that inventory thing was down -20.8%. The number of Months inventory fell 36% statewide from 5.0 months in 2020 to 3.2 months in 2021.

Demand is strong as I have been reporting for a long time now while supply is very limited. Mortgage rates are still very low. According to Freddie Mac, the monthly average on a 30-year fixed-rate mortgage in August was down to 2.84% – the lowest rate in the past six months.
